## Undertaking by the applicant

We have studied the provisions of the “Regulations for Nordic Ecolabelling of products“.

If our application for registration is granted, we undertake to follow these regulations and the ecolabelling criteria and other regulations of which we are notified by the ecolabelling organisation.

We thus undertake to follow above mentioned regulations, which gives rise to the following typical obligations

- to conform to the relevant official requirements concerning the outdoor and indoor environment in all handling of the product,
- to use the ecolabel only on products which conform in all respects to the provisions of the relevant ecolabelling criteria,
- not to use the ecolabel on products other than those covered by this registration,
- to follow the rules for the use of the Nordic ecolabel according to paragraph 11 in the “Regulations for Nordic Ecolabelling of products“,
- to give reliable information on the implications of ecolabelling in the marketing of ecolabelled products in advertisements and other publicity,
- to pay the required fees to the ecolabelling organisation and other costs related to our application and inspection and testing of ecolabelled products that are specified in the relevant ecolabelling criteria and other regulations,
- to indemnify the ecolabelling organisation in the event of claims for damages or other economic disbursements which the ecolabelling organisation has incurred as a result of damage caused by a product manufactured and/or sold by the licensee, which also includes faults and shortcomings of the product itself.

The Agreement giving the applicant a right to use and refer to the Nordic *Swan* ecolabel comes into force when the environmental organisation has issued the registration.
